Agreement to Hire Caller

This agreement dated August 30, 2010 is between **SOUTH WINDSOR SQUARE DANCE CLUB, INC** ("SWSDC"), a non-profit western square dance club based in South Windsor CT and **DON BECK** of 9 Shaler's Way, Chilmark MA 02535 ("CALLER")

SWSDC and CALLER hereby agree to the following:

1. CALLER is hired for the verbally agreed upon a fee of \$130.00 (one hundred thirty dollars)and a surcharge of \$10 (ten dollars) for paid squares over SIX to call a western square dance for SWSDC on **JANUARY 24, 2014**, ("dance date"). Hours of the dance are from 8:00 PM to 10:45 PM
2. Site of the dance will be **POWDER MILL BARN**, 32 South Maple St, Hazardville (Enfield) CT. Directions to be found at <http://fhrick.net/SWSDC/>
3. CALLER is hired to call a regular dance with an alternating Mainstream/Plus level of calls. However, CALLER agrees to use his expertise to adjust the calls as needed to floor level.
4. **CALLER certifies that he will be licensed on dance date by ASCAP and BMI to perform copyrighted music for SWSDC.**
5. CALLER agrees to provide his/her own equipments and to adjust the speed and volume of its use as requested by SWSDC.
6. CALLER agrees in the case of inclement weather or illness to notify SWSDC as early as possible whether he will be calling on dance date. CALLER understands there will be no payment made by SWSDC for any last minute cancellations of CALLER'S services due to weather/illness. SWSDC will secure the replacement.
7. SWSDC agrees that in case of inclement weather that leads to dance venue closure, SWSDC shall notify CALLER as early as possible on callers need for that night. CALLER understands there will be no payment made by SWSDC for any last minute cancellations of caller's services due to weather.
8. SWSDC and CALLER agree that this agreement may be canceled by either party providing the other party with **Written Notice** at least sixty (60) days in advance.
9. SWSDC and CALLER agree that should financial conditions deteriorate for SWSDC, a mutually acceptable fee adjustment may have to be renegotiated at least sixty (60) days in advance of dance date.

10. SWSDC and CALLER agree to all conditions stated in this agreement. It is further agreed and understood that there are no considerations or guarantees expressed or implied except as stated explicitly herein.
